WARNING!

RISK OF ACCIDENTS OR FATAL INJURY FOR INFANTS AND

CHILDREN! Never leave children unsupervised with the packaging material. There is a danger of suffocation from the packaging material. Children often underestimate the dangers. Always keep children away from the product.

- This product can be used by children aged 8 years and over, as well as by persons with limited physical, sensory or mental abilities or lacking in experience and knowledge, if they are supervised or have been instructed as to the safe use of the product and understand the resulting hazards. Do not let children play with the product. Cleaning and maintenance may not be carried out by children without proper supervision.
- Do not use the product if you notice any defects.
- The row of lights must not be connected to the mains power supply while still in the packaging.
- Once the light has reached the end of its service life, it must be disposed of in accordance with local disposal regulations. The LEDs are non-replaceable.
- The light must not be used without the sealing ring 8 properly fitted to the cable (see Fig. B)!
- If using the product outdoors, you should only ever connect the mains adaptor 5 to an IP44-rated socket (see Fig. B).
- RISK OF INJURY! When removing the light, make sure that you also remove the ground spike 3 so as to avoid any risk of injury (e.g. trip hazard) (see Fig. A).
- TRIP HAZARD! Please make sure that the power cable 4 is routed in such a way that nobody can tread on it or trip over it (see Fig. A).

Assembly

Please note: Dispose of all packaging material.

Please note: Only use the mains adaptor 5 supplied with the product (see Fig. B). ☐ Fit the LED strip light 1 together with the extension 2 and ground spike 3 (see Fig. A), making sure that the cable remains inside the tubes and does not become pinched or severed between them (see Fig. C).

Now connect the power cable 4 to the mains adaptor 5 and then screw the sleeve nut 9 tightly onto the mains adaptor 5 (see Figs. A and B).

RISK OF INJURY! When removing the light, make sure that you also remove the ground spike 3 so as to avoid any risk of injury (e.g. trip hazard) (see Fig. A).

Operating the LED strip lights

- Plug the mains adaptor supplied into an IP44-rated socket designed for the purpose. The article will light up in permanently on mode.
- ☐ To activate the timer function, press the button marked "PRESS" 6. The button will then light up green.
- To switch off the article, press the button marked "PRESS" 6 again.

Cleaning and storing

- Switch off the product by pressing the button marked "PRESS" 6 if you wish to stop using it, clean it and store it away (see Fig. B).
- Regularly inspect the LED strip lights for dirt and contamination. Remove any dirt to ensure the product works correctly.
- Clean the product with a clean, damp cloth and a mild detergent.

Warranty

Dear customer, This product comes with a 3-year warranty from the date of purchase. In the event that this product is faulty, you have legal rights against the seller of the product. These statutory rights are not restricted by our warranty as set out below.

Warranty terms

The warranty period begins with the date of purchase. Please keep the original receipt in a safe place. It is required as proof of purchase. If a material or manufacturing defect occurs within three years of the date of purchase, we will repair or replace the product for you free of charge, or refund the purchase price, at our discretion. This warranty service is granted provided that the faulty device and the proof of purchase

(receipt) are presented within three years, along with a brief written description of the fault and of when it occurred. If the fault is covered by our warranty, we will return the fixed product or send you a new one. No new warranty period shall begin upon repair or replacement of the product.

Warranty period and statutory warranty claims

The warranty period is not renewed after a warranty service has been granted. This rule shall also apply for any replaced or repaired parts. Any damage or faults that already existed when buying the product must be reported immediately upon unpacking the product. A fee is charged for any repairs that are carried out after the end of the warranty period.

Warranty scope

The device was carefully manufactured according to the strictest quality guidelines and thoroughly tested before delivery. The warranty applies to material or manufacturing defects. This warranty does not apply to product parts that are subject to normal wear and tear and can therefore be regarded as wearing parts, or damage to fragile parts, such as switches, rechargeable batteries or parts that are made of glass. This warranty is void if the product has been damaged, improperly used or serviced. To ensure proper use, all instructions included in the manual must be followed carefully. All uses and actions that users are discouraged from or warned of in the manual must be avoided under all circumstances. The product is intended for private household use only, and not for commercial activities. The warranty is void, if the product is treated inappropriately, if force is applied, and in the case of any manipulation that is not carried out by our authorised service branch.
